

## MANAGEMENT BOARD DECISION No 23/2015

of 15 June 2015

### ON IRELAND'S PARTICIPATION IN FRONTEx JOINT RETURN OPERATION TO DEMOCRATIC REPUBLIC OF CONGO ORGANISED BY BELGIUM ON 17 JUNE 2015

#### THE MANAGEMENT BOARD

Having regard to the Frontex Regulation<sup>1</sup>, in particular Article 20(5) thereof,

Whereas:

- (1) Article 1 of Management Board Decision 31/2007 on the practical arrangements for participation of Ireland in Frontex' operational activities<sup>2</sup> stipulates that *"Within two months after the adoption of the Frontex Annual Work Programme, Ireland may submit an Annual Request to participate in some or all of the activities listed in the Programme. The Annual Request shall include reference to Ireland's financial contribution. The Management Board decides on the Annual Request for Ireland's participation by the majority stipulated in Article 20(5) of the Frontex Regulation."*
- (2) Article 2 of Management Board Decision 31/2007 states that *"On the basis of the activities in the Annual Request in which Ireland has been allowed to participate, Ireland shall submit a Specific Request for each particular activity in which it is willing to participate"*;

The Management Board by its Decision no. 17/2015 of 13 May 2015 approved IE's Annual Request to participate and contributed financially to operational activities coordinated by Frontex in 2015. Based on this Annual Request, IE submitted a Specific Request for its participation in the Joint Return Operation to Democratic Republic of Congo organized by Belgium on 17 June 2015.

- (3) On 10 June 2015, Frontex invited the Management Board on behalf of the Management Board Chairperson to take a decision on Ireland's participation in Frontex Joint Return Operation to Democratic Republic of Congo organized by Belgium on 17 June 2015.  
In accordance with Article 2(4) of Management Board Decision 31/2007, the Management Board decides on a Specific Request by written procedure, approving or rejecting the proposal in its entirety;
- (4) Pursuant to Article 2(5) of the Management Board Decision 31/2007, tacit approval for Ireland's participation is considered to have been given in the absence of sufficient number of explicit objections;

- (5) No objections to the participation of Ireland in Frontex Joint Return Operation to Democratic Republic of Congo organized by Belgium on 17 June 2015 have been received by Frontex.

**HAS DECIDED AS FOLLOWS:**

Ireland's Specific Request to participate in Frontex Joint Return Operation to Democratic Republic of Congo organized by Belgium on 17 June 2015 has been approved on 15 June 2015.
