

MANAGEMENT BOARD DECISION No 28/2015 of 2 September 2015

on the United Kingdom's participation in Frontex JO EPN Triton and JO EPN Poseidon Sea

THE MANAGEMENT BOARD

Having regard to the Frontex Regulation¹, in particular Article 20(5) thereof,

Whereas:

- (1) Article 1 of Management Board Decision 21/2008 on the practical arrangements for participation of the UK in Frontex' operational activities² states that *"Within two months after the adoption of the Frontex Annual Work Programme, the UK may submit an Annual Request to participate in some or all of the activities listed in the Programme. The Annual Request shall include reference to the UK's financial contribution. The Management Board decides on the Annual Request for the UK's participation by the majority stipulated in Article 20(5) of the Frontex Regulation"*;
- (2) Article 2 of Management Board Decision 21/2008 states that *"On the basis of the activities in the Annual Request in which the UK has been allowed to participate, the UK shall submit a Specific Request for each particular activity in which it is willing to participate"*;
- (3) The Management Board by its Decision 14/2015 of April 2015 approved the UK's Annual Request to participate and contribute financially to operational activities coordinated by Frontex in 2015. Based on this Annual Request, the UK submitted a Specific Request for its participation in JO EPN Triton and JO EPN Poseidon Sea from 03.09.2015 to 19.12.2015.
- (4) On 28/08/2015 Frontex invited the Management Board on behalf of the Management Board Chairperson to take a decision on the UK's participation in Frontex JO EPN Triton and JO EPN Poseidon SEA. In accordance with Article 2(4) of Management Board Decision 21/2008, the Management Board decides on a Specific Request by written procedure, approving or rejecting the proposal in its entirety;
- (5) Pursuant to Article 2(5) of the Management Board Decision 21/2008, tacit approval for the UK's participation is considered to have been given in the absence of sufficient number of explicit objections;
- (6) No objections to the participation of the UK in Frontex JO EPN Triton and JO EPN Poseidon Sea have been received by Frontex.
