

**MANAGEMENT BOARD DECISION No 41/2015**  
**of 30 October 2015**

**on the United Kingdom's participation in Frontex JO Flexible  
Operational Activities in Return 2015 (FOA-R),  
JO EPN Triton 2015 and JO EPN Poseidon Sea 2015**

**THE MANAGEMENT BOARD**

Having regard to the Frontex Regulation<sup>1</sup>, in particular Article 20(5) thereof,

Whereas:

- (1) Article 1 of Management Board Decision 21/2008 on the practical arrangements for participation of the UK in Frontex' operational activities<sup>2</sup> states that *"Within two months after the adoption of the Frontex Annual Work Programme, the UK may submit an Annual Request to participate in some or all of the activities listed in the Programme. The Annual Request shall include reference to the UK's financial contribution. The Management Board decides on the Annual Request for the UK's participation by the majority stipulated in Article 20(5) of the Frontex Regulation"*.
- (2) Article 2 of Management Board Decision 21/2008 states that *"On the basis of the activities in the Annual Request in which the UK has been allowed to participate, the UK shall submit a Specific Request for each particular activity in which it is willing to participate"*.
- (3) The Management Board by its Decision 14/2015 of 14 April 2015 approved the UK's Annual Request to participate and contribute financially to operational activities coordinated by Frontex in 2015.
- (4) Since the participation in JO FOA-R 2015, JO EPN Triton 2015 and JO EPN Poseidon Sea 2015 was not foreseen in the UK's annual request, the UK submitted a Specific Additional Request for its participation in JO FOA-R 2015 from 1.11.2015 to 31.01.2016, JO EPN Triton 2015 from 01.12.2015 to 18.12.2015 and JO EPN Poseidon Sea 2015 from 3.11.2015 to 31.01.2016, pursuant to Article 3 of MB Decision 21/2008.
- (5) On 23/10/2015 Frontex invited the Management Board on behalf of the Management Board Chairperson to take a decision on the UK's participation in Frontex JO FOA-R 2015, JO EPN Triton 2015 and JO EPN Poseidon Sea 2015. In accordance with Article 2(4) of Management Board Decision 21/2008, the Management Board decides on a Specific Request by written procedure, approving or rejecting the proposal in its entirety.

- (6) Pursuant to Article 2(5) of the Management Board Decision 21/2008, tacit approval for the UK's participation is considered to have been given in the absence of sufficient number of explicit objections.
- (7) No objections to the participation of the UK in Frontex JO FOA-R 2015, JO EPN Triton 2015 and JO EPN Poseidon Sea 2015 have been received by Frontex.

## **HAS DECIDED AS FOLLOWS:**

### *Article 1*

The UK's Specific Additional Request to participate in Frontex JO FOA-R 2015, JO EPN Triton 2015 and JO EPN Poseidon Sea 2015 has been approved on 30 October 2015.

### *Article 2*

#### **Entry into force**

This decision enters into force on the day of its adoption.
